**NOTICE FOR DIVERSION OF PANEL**

Based on the Railway Board's letter No. 2015/E(RRB)/23/1 dated 07.02.2017, the available 25 standby panel papers with Railway Recruitment Board, Bilaspur for the post of Assistant Station Master against CEN No.03/2012 is being diverted to East Central Railway for the post of Assistant Station Master to be inducted on this Railway on permanent basis.

This includes the originals of all certificates produced during document verification and attached with application form, if any (b) vacancies are available (c) they pass prescribed medical examination (d) complete the requisite administrative formalities/procedures and (e) their thumb impression, photograph, signature, handwriting and other details in their applications match before appointment/actual joining.

If at a later date, any candidate is found to be debarred by any RRB or any discrepancies/irregularities detected in respect of qualification, age, community etc, then their candidature/appointment will be cancelled.
