NOTICE FOR DIVERSION OF PROVISIONAL PANEL OF ECRC
AGAINST CEN NO. 03/2012 NTPC(G)

As per Railway Board's letter No. 2015/E(RRB)/23/5 dated 28.10.2015 and break-up received from Railways for the post of Enquiry cum Reservation Clerk Category No. 03, panel of 31 candidates (30 candidates returned from SECR and 1 Ex-Serviceman) is being diverted to NFR, SER, NR, and WR. The present allotment for ECRCs is made by utilizing the vacancies available on NFR, SER, NR, and WR in proportion to the surplus papers available with the two RRBs (RRB Mumbai & RRB Bilaspur) vis-à-vis the options received from the candidates.

The panels of the above candidates are diverted in terms of Clause No 13.07 of CEN 03/2012 which reads as under:

13.07: "Candidates finally selected are liable to be posted anywhere on Indian Railways, if required".

Wherever no option was submitted, the allotment of Railway is done on the basis of merit cum nearest Zonal Railway from the place of residence of such candidates.

The selected candidates should note that the final result is provisional and empanelment is subject to submission of the required documents by the candidates, wherever the same is not submitted and further verification of candidature and relevant documents by the concerned Railway; hence does not confer on them any right to appointment on Railways unless (a) They produce original certificates of educational qualification, age & community etc. in support of their eligibility before the concerned Railway. This includes the originals of all certificates produced during document verification and attached with application form, if any (b) vacancies are available (c) they pass prescribed medical examination (d) complete the requisite administrative formalities/procedures and (e) their thumb impression, photograph, signature, handwriting and other details in their applications match before appointment/actual joining.

If at a later date, any candidate is found to be debarred by any RRB or any discrepancies/irregularities detected in respect of qualification, age, community etc, then their candidature/appointment will be cancelled.
