**PROVISIONAL FINAL PANEL FOR  
HEALTH AND MALARIA INSPECTOR GR III, CATEGORY NO 2 AND  
SUPPLEMENTARY PANEL FOR PHARMACIST GR III, CATEGORY  
NO 3 AGAINST CEN 04/2014**

The vacancy position and number of candidates empanelled provisionally for the post of Health and Malaria Inspector Gr. III is annexed as **ANNEXURE-I**.

Based On the performance of written test on 08/02/2015 and verification of candidature and documents on 03/06/2015 for the above mentioned post, the candidates listed in **ANNEXURE-II** have been provisionally found successful for empanelment for the said post against normal vacancy. The Railways allotted is also shown against each. The Roll numbers are given in ascending order.

The selected candidates should note that the final result is provisional and empanelment is subject to verification of candidature and relevant documents by the concerned Railway, hence does not confer on them any right to appointment on Railway unless (a) They produce original certificates of educational qualification, age and community etc, in support of their eligibility before the concerned Railway. This includes the originals of all certificates produced during document verification and attached with application form, if any (b) vacancies are available (c) they pass prescribed medical examination (d) complete the requisite administrative formalities/procedures and (e) their thumb impression, photograph, signature, handwriting and other details in their applications match before appointment/actual joining.

Similarly, the list indicating Roll Numbers of candidates in ascending order who were lower in merit and could not be considered for empanelment due to non-availability of vacancies, although they were called for document verification is attached as **ANNEXURE-III**. These candidates are placed in standby list. There is no guarantee for empanelment of these candidates. Their names may only be considered for empanelment in due course if the indenting Railways ask for replacement panel within the specified time from this RRB against the shortfall due to selected candidates having been declared medically unfit or the selected candidates did not respond to the offers sent by Railways to them.

Pursuant to the issuance of Show Cause Notice and considering their reply, the candidature of candidates as per **Annexure-IV**, stands finally rejected since they do not possess the requisite qualification as per CEN 04/2014. No correspondence in this regard will be entertained.

Similarly, in the Panel Notice No RRB/BSP/Result-Panel/04-2014/PARAMEDICAL/424 Dated 09.07.2015, result of one candidate was kept withheld for non-submission of No Objection Certificate from employer. Accordingly, a Show Cause Notice Dated 09.07.2015 was issued to the candidate but no response was received. Hence his candidature is finally rejected. As a natural corollary, one candidate from stand by list is placed in the final panel, the details of which are given in **Annexure-V**.

If at a later date, any candidate is found to be debarred by any RRB or any discrepancies/irregularities detected in respect of qualification, age community etc, then his candidature/appointment will be cancelled.
