This includes the originals of all certificates produced during document verification and attached with application form, if any (b) vacancies are available (c) they pass prescribed medical examination (d) complete the requisite administrative formalities/procedures and (e) their thumb impression, photograph, signature, handwriting and other details in their applications match before appointment/actual joining.

Cut off marks of the selected candidates are given in **ANNEXURE-III**. Since eligible candidates are not available as per the notified vacancies there is a shortfall of one (1) UR candidate. Also no candidates are found to be placed in additional list as given in **ANNEXURE-IV**. All the successful candidates called for document verification have attended the process of verification of candidature and documents. As such list of absent candidates is given in **ANNEXURE-V**.

If at a later date, any candidate is found to be debarred by any RRB or any discrepancies/irregularities detected in respect of qualification, age, community etc, then his candidature/appointment will be cancelled.
