- 11.0 As per Para 1.13 of General instructions in CEN 02/2024 "The allotment of category/post/Railway will be based on merit, post preference, medical fitness and vacancy availability on the date of panel preparation. After the category/post/Railway is allotted by RRB, candidates forfeit the right to be considered for any other post /category within that pay Level."
  - Accordingly, post/Railway option of already empanelled candidates is not changed and revised cut off is published as per suitable candidates available after Panel-1 & 2.
- 12.0 Result of candidates having their marks same as cut off marks, have been decided as per para 13.2 of CEN notification.
- 13.0 Publication of revised cutoff is being done wherever there is any change in the marks of the lowest candidate selected/called for DV. Hence no revised cutoff is published where no change in the lowest marks of candidate for any post/community.
- 14.0 Panels of Tech-I is completed. This is a part panel against Tech III Posts and further panels of the eligible candidates shall be published in due course after completion of next round of document verification.
- 15.0 Important: Beware of the touts who may misguide the candidates with false promises of getting them selected for the job on illegal consideration. The recruitment process in the RRB exams is fully computerised and the selection is based purely on the merit of candidates.
