REPLACEMENT PANEL NOTICE

In continuation to this office result notice No. RRB/BSP/Diversion-Panel/04-2010/TC/507 dated 03.01.2017 published for the post of Ticket Collector in pay band Rs.5200 – 20200, Grade Pay Rs.1900/- and on the basis of the demand received for replacement from the West Central Railway, Jabalpur, allotment of 30 standby candidates from the available Combined Standby List is being done provisionally for the post of Ticket Collector on replacement basis as per the order of merit.

The Roll Numbers of these 30 candidates are listed in **Annexure-I** and they are being empanelled for the post of Ticket Collector over West Central Railway, Jabalpur on replacement basis as per the approval of the Railway Board in terms of Clause No. 13.06 of CEN 04/2010 which reads as under:-

13.06 : “Candidates finally selected are liable to be posted anywhere on Indian Railways, if required.”

The candidates listed therein should note that this replacement panel is provisional and empanelment is subject to verification of candidature and relevant documents by the concerned Railway, hence, does not confer on them any right to appointment on Railway unless (a) They produce original certificates of educational qualification, age and community etc, in support of their eligibility before the concerned Railway. This includes the originals of all certificates whose xerox copies were attached with the application form for the post of Ticket Collector (b) vacancies are available (c) they pass prescribed medical examination (d) complete the requisite administrative formalities/procedures and (e) their thumb impression, photograph, signature, handwriting and other details in their applications match before appointment/actual joining.

If at a later date, any candidate is found to be debarred by any RRB or any discrepancies/irregularities detected in respect of qualification, age community etc, then his candidature/appointment will be cancelled.

While every care has been taken in preparing the replacement panel, Railway Recruitment Board, Bilaspur, reserves the right to rectify errors and omissions at any stage if any.
